Covers Environmental, Social, and Governance factors.

3 Phased Implementation

Different deadlines based on company size and type.

### 1 Double Materiality

### 3 Forward-Looking Information

### 5 Auditing

Your sustainability information will need to be independently audited, adding a new layer of scrutiny.

#### **4** Value Chain Considerations


Your reporting now needs to encompass your entire value chain, not just your direct operations.
